STATEMENT OF POLICY

We breed only those parents who have hip, eye and heart clearances or evaluation reports by qualified veterinarians. The Orthopedic Foundation for Animals (OFA) and the Canine Eye Registry Foundation (CERF) issue certificates of clearances for hips and eyes respectively. PennHip (Issues a Hip Evaluation Report). In some instances, a parent may not have a CERF certificate but the examining ophthalmologist's clearance is available in its place. Heart clearances are performed by a Veterinarian with the designation of Diplomat in Cardiology (ACVIM) or sometimes by a licensed general practice veterinarian.

Your puppy has been bred from many generations of ancestors most of whom who have clearances or evaluation reports for hips within the recommended breeding criteria determined by the respective organizations. This does not guarantee that your puppy will not develop hip dysplasia. The development of canine hip dysplasia is not dependent only upon genetics but environment (exercise, injuries and feeding) as well. Over feeding and inappropriate exercise can harm immature developing joints and may affect their ultimate development. **Concerning Hips:** There are many contributing factors to the development of Hip Dysplasia so **WE DO NOT GUARANTEE AGAINST HIP DYSPLASIA.**

Your puppy has been examined by a qualified veterinarian and determined to be healthy. The breeder is NOT responsible for any tests, surgery, etc. the buyer elects to perform on the above-mentioned puppy. There are unforeseen diseases and illnesses that affect all living things, these illnesses and diseases are not predictable and the breeder assumes no responsibility for such.

The Buyers of this puppy have been made aware that the breeder will always welcome this dog back into her home if there is ever any reason that the buyers cannot keep this dog.

The purchaser of this puppy understands that they are purchasing a pet quality puppy and they understand that the LIMITED REGISTRATION given by AKC does not allow for registration of any get produced by this dog through AKC and that they may not participate in AKC sanctioned conformation shows. Buyer(s) agree(s) that they will not breed this dog.

Concerning Male Puppies: Occasionally there is a male puppy whose testicle(s) has not descended by the time he is seven or eight weeks old or has descended but is retracted. Sometimes the testicle(s) will descend later; however, I cannot guarantee that this will occur. If the testicle(s) does not descend it is recommended that your puppy be neutered; of course neutering is always recommended for the home companion golden. It is understood by you, the buyer, that there is no guarantee or refund if one or both testicle(s) fail to descend.

Disclosure by Seller required by Delaware Code concerning Pet Warranties: This animal has no known disease or illness, nor any known congenital or hereditary condition that adversely affects the health of the animal at the time of sale or is likely to adversely affect the health of such animal in the future. The exceptions to this statement are any disclosures concerning this puppy of any disease or illness noted on this policy.

Buyer hereby acknowledges that an AKC registration application ("A pedigree or a registration does not assure proper breeding condition, health, quality or claims to lineage."), statement of policy, health record, and a copy of Delaware Code #Title 6, Subtitle II, Chapter 40, Pet Warranties was received, read, and agreed to and understood. If the AKC application is not available the breeder(s) will forward it to the buyer as soon as it is received from AKC.
